### CONDITIONS OF ENTRY

1. The event is run in accordance with EQ regulations
2. Entry will not be accepted if insufficient money is enclosed and form is not signed. The nomination form will be returned to you as per recommendation of EQ.
3. EQ self adhesive competition labels MUST be used on the Entry Details form. BRIDLE Numbers must be noted
4. You must be a current financial member of the EQ Inc. otherwise entry will be refused.
5. Scratchings will be accepted up to 9am of the day after the entries close. Refund of entry fees (less 50% administration costs) after that time will only be made on submission of a vet certificate or a Doctors certificate up to 24 hours after the date of the event;
6. Riders who are under the age of 18 must be under the supervision of a parent or guardian at all times during the competition
7. Current ASA Helmet must be worn at all times while mounted on a horse, including warm up and parking areas. You may be required to provide proof your helmet is current AS/NZS 3838: 1998.
8. It is the competitors' responsibility to present to gear check before each test.
9. Maximum of three horses per rider and a maximum of three classes per horse over two consecutive levels
10. Classes may be restricted to 35 riders and RASDEG members will be given preference.
11. If less than 10 competitors in a class, prize money will be adjusted accordingly.
12. Entry fee is deemed to be \$20.00 per class with regards to calculation of prize money.
13. Callers are permitted however competitors must make their own arrangements; RASDEG officials are not responsible for the organisation of callers.
14. Dogs are NOT allowed on the grounds
15. If the event is cancelled RASDEG may retain an administration fee of 30% of the total entry fee to cover costs incurred
16. Protests to be lodged with the appeal committee in writing and accompanied by \$150 not later than half hour after the incident that gave rise to the protest.
17. It is the competitors' responsibility to ensure their equipment meets EQ & safety regulations. If a competitor's conduct or equipment in anyway compromises the safety of others, entry will be refused.
18. As per EQ regulations, no electronic or ropeyards are permitted at any RASDEG competition.
